Minutes of the Annual Board Meeting

1. Call to order

The Annual Meeting of Forest Lakes Owners Association was called to order at 7:06 PM by Karen Foncannon. Karen led the group in the pledge of allegiance.

2. Election of Board Members

Karen asked if there were any write-ins in addition to the two members that were up for re-election and there were none. Jane Cummins nominated Judy Summers for a position on the board. 3. Fire Department

Chief Rodriguez reported that the Fire Department is looking into buying a used ambulance from a neighboring Fire Department for \$15,000.00. He will report on the progress of this purchase at a later date.

Three of the four will be voted for in the Coconino County General Election held in November.

4. Fire Auxiliary Report

Jan Walls reported that over \$4000.00 was made on T-shirt sales from the three main events held during the year. The Auxiliary made over \$500.00 in profits from the Ice Cream Socials. All the money earned from the events will be used to help the Fire Department .

5. Water Board Report

Mary Hume reported that the Water Board helped with snow removal and provided food to the fire fighters during the emergency. She also encouraged all residents that will not be coming to Forest Lakes during the winter months to go to the Water Department and sign up for the automatic turn-off and turn-on service that will be done November 1st and April 30th. There is a cost of \$25.00 for this service.

6. School Board Report

Cliff Schweigert brought a drawing of the proposed new building which will replace the existing building where the library is currently. He pointed out that there are numerous problems with the progress and that the new building will not be started this year. The permits will be obtained over the winter months and hopefully the building will start in the Spring. The drawing is on display in the library.

7. Volunteer of the Year Award

The Volunteer of the Year Award was given to Wendell and Deb Lolling. Karen presented the Lollings with a gift of appreciation.
